## **FOOD TRUCK OBLIGATIONS AT THE EVENT:**

Food Vendors **MUST** register by completing this application as well as completing the Temporary Food Service Vendor Application and Permit , We do **NOT** take care of this for you. You must make sure you have all your proper obligations in order. This form must be submitted at least 14 days prior to the event in order to be approved. Electric is **NOT** provided. Please make sure you have proper permits and paperwork!

## **GUIDELINES FOR SELLING AT THE EVENT:**

- **Sellers must have a sign clearly showing their name and location. Each seller will be responsible for all equipment and supplies for the setup of a booth. Displays should be constructed so they do not block customer walkways or pose any other hazard to customers.**
- **Vendors who provide samples and/or products that will result in waste material, such as cups, rinds, and utensils, must provide containers for waste disposal. You must wear gloves when handling food and have a wash station to sanitize serving materials and your hands and adhere to all food service standards as set up in local laws and municipalities.**
- **Sellers are required to keep your space neat and clear of obstacles, litter, and debris.**
- **No form of discrimination is permitted at the event.**
- **Sellers are expected to treat customers in a courteous manner. ● Sellers must clean their sales area and remove all refuse at the end of the day. Event organizers are not responsible for trash removal or cleanup. All trash removal and clean up is the responsibility of the vendor.**
- **Vendor tents **MUST** be weighted or tethered down. No vendor will be allowed to set up without a properly secured tent.**
